Report on the Financial Statements

We have audited the accompanying cash basis financial statements of the governmental activities, the business-type activities, the aggregate discretely component units, each major fund, and aggregate remaining fund information of the City of Carl Junction, Missouri, as of and for the year ended April 30, 2015, and the related notes to the financial statements, which collectively comprise the City's financial statements as listed in the table of contents.

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the cash basis of accounting described in Note 1; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error.

In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the financial statements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis for Adverse Opinion on U.S. Generally Accepted Accounting Principles

As described in Note 1 to the financial statements, the financial statements are prepared using the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America.

The effects on the financial statements of the variances between the cash basis of accounting described in Note 1 and accounting principles generally accepted in the United States of America, although not reasonably determinable, are presumed to be material.

Adverse Opinion on U.S. Generally Accepted Accounting Principles

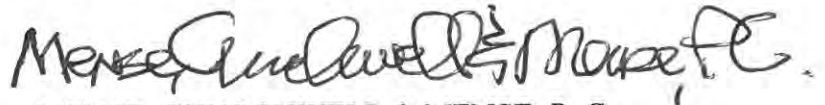
In our opinion, because of the significance of the matter discussed in the "Basis for Adverse Opinion on U.S. Generally Accepted Accounting Principles" paragraph, the financial statements referred to above do not present fairly, in conformity with accounting principles generally accepted in the United States of America, the financial position of the City of Carl Junction, Missouri as of April 30, 2015, or changes in financial position and cash flows thereof for the year then ended. Further, the City has not presented a management's discussion and analysis that accounting principles generally accepted in the United States of America has determined is necessary to supplement, although not required to be a part of, the financial statements.

Basis for Qualified Opinion on Cash Basis of Accounting

The Statements of General Fund and Special Revenue Fund receipts, expenditures, and cash balances do not include all the Municipal Bond and Court Fund receipts and expenditures for the year ended April 30, 2015. The amount by which this omission would affect the receipts, expenditures and cash balances has not been determined.

Qualified Opinion on Cash Basis of Accounting

In our opinion, except for the effects of the matter described in the "Basis for Qualified Opinion on Cash Basis of Accounting" paragraph above, the financial statements referred to above present fairly, in all material respects, the cash balances of the City of Carl Junction, Missouri as of April 30, 2015, and the cash receipts and expenditures, and budgetary results for the year ended in accordance with the financial reporting basis of accounting described in Note 1.

I. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

I.A. INTRODUCTION

The City of Carl Junction, Missouri is incorporated and operates as a fourth class city as provided for in Chapter 79 of the Missouri Revised Statutes (RSMO). The City operates under an elected Mayor/Board of Aldermen/City Administrator form of government. The City's major operations include health services, public safety, recreation and parks, and general administrative services. In addition, the City provides water and sewer services.

The accompanying financial statements present the cash receipts, disbursements, and changes in cash balances of all funds of the City of Carl Junction, Missouri, and comparisons of such information with the corresponding budgeted information for the General Fund, Special Revenue Funds, Debt Service Fund, Capital Projects Fund, and Enterprise Fund.

I.B. FINANCIAL REPORTING ENTITY – BASIS OF PRESENTATION

I.B.1. These financial statements present the financial information of the City of Carl Junction, Missouri, the primary government.

Component units of the City are based on significant influence which the City exercises over such units. Significant influence or accountability is based primarily on operational or financial relationships with the City (as distinct from legal relationships). The City has no component units.

I.B.2. FUNDS AND ACCOUNT GROUPS

The accounts of the City are organized on the basis of funds, each of which is considered to be a separate accounting entity. Fund accounting is designed to demonstrate legal compliance and to aid financial management by segregating transactions related to certain government functions or activities.

Governmental Fund Types

General Fund – The General Fund is the general operating fund of the City. All financial resources, except those required to be accounted for in another fund, are accounted for in the General Fund.

Special Revenue Funds – Special Revenue Funds are used to account for the proceeds of special revenue sources that are legally restricted to expenditures for specific purposes.

I.B.2. FUNDS AND ACCOUNT GROUPS (CONTINUED)

Governmental Fund Types (Continued)

Debt Service Fund – The Debt Service Fund is used to account for the accumulation of resources for, and payment of governmental fund type debt including general obligation bonds.

Capital Projects Fund – The Capital Projects Fund is used to account for transfers from the General Fund and proceeds from grants which are used for payment on City construction projects.

Proprietary Fund Types

Enterprise Funds – Enterprise Funds are used to account for operations that are financed and operated in a manner similar to private business enterprises where the costs of providing water and sewer services to the general public on a continuing basis are financed through user charges.

I.C. BASIS OF ACCOUNTING

Basis of accounting refers to when revenues and expenditures or expenses are recognized in the accounts and reported in the financial statements. Basis of accounting relates to the timing of the measurements made, regardless of the measurement focus applied.

The financial statements are prepared on the cash basis of accounting wherein amounts are recognized when received or disbursed. This basis of accounting differs from accounting principles generally accepted in the United States of America, which require revenues to be recognized when they become available and measurable or when they are earned, and expenditures or expenses to be recognized when the related liabilities are incurred.

I.D. BUDGETARY DATA

The City is required by State Statutes to prepare an annual operating budget. The budget shall present a complete financial plan for the ensuing budget year and shall include at least the following information:

I.D. BUDGETARY DATA (CONTINUED)

- (1) A budget message;
- (2) Estimated receipts and a comparative statement of actual or estimated receipts for the two preceding years itemized by year, fund, and source;
- (3) Proposed disbursements together with a comparative statement of actual or estimated disbursements for the two preceding years itemized by year, fund, activity and object;
- (4) Amount required for debt payment; and
- (5) A general budget summary.

The Board of Aldermen follows these procedures in the preparation of the budget:

- (1) Prior to May 1, City Administrator submits to the Board of Alderman a proposed operating budget for the fiscal year commencing May 1.
- (2) Public hearings are conducted to obtain taxpayer comment.
- (3) Prior to May 1, the budget is legally enacted through passage of an ordinance.
- (4) Formal budgetary integration is employed as a management control device during the year for the General Fund, Special Revenue Funds, Debt Service Fund and Proprietary Funds.

The budget may be revised. If total disbursements are increased the City shall adopt a resolution setting forth the facts and reasons making the increase necessary. In no event shall total authorized expenditures from a fund exceed the estimated revenues plus the unencumbered beginning balance. The budgets were amended during the year.

I.E. CASH AND INVESTMENTS

The City maintains a demand deposit account that is available for use by all funds. Cash applicable to a particular fund is readily identifiable.

I.E. CASH AND INVESTMENTS (CONTINUED)

The City is allowed to invest in obligations of the United States Government or any agency thereof, maturing and becoming payable not more than three years from date of purchase. In addition the City may enter into repurchase agreements maturing and becoming payable within ninety days, secured by United States Governmental Agencies or Instrumentalities of any maturity.

I.F. CASH RECEIPTS AND DISBURSEMENTS

I.F.1 Sales Tax

The City levies a one percent sales tax, a one-half percent transportation, a one-half percent park/stormwater and one-half percent capital improvements on taxable sales within the City. The tax is collected by the Missouri Department of Revenue and remitted to the City. Pursuant to ordinance the transportation tax is restricted to street improvements and repairs, and the capital improvements tax is restricted to capital improvement projects.

I.F.2 Property Taxes

Property taxes are an enforceable lien on property as of January 1. Taxes are levied November 1 and are due and payable in full by December 31; unpaid taxes become delinquent after December 31. The City bills and collects its own property taxes.

I.F.3 Compensated Absences

Vacation and sick leave are considered to be expenditures in the year paid. Vacation leave may accrue from year to year. An employee may accumulate up to 30 days of vacation leave. Unused vacation leave is paid in the event of termination. At April 30, 2015 the estimated unused accrued vacation leave amounted to approximately \$52,507.65. Unused sick leave is forfeited upon termination. At April 30, 2015, the estimated unused accrued sick leave amounted to approximately \$152,234.80. The City compensates employees for overtime worked by accruing compensatory time off at the rate of 1.5 times the employee's normal rate of pay and 2 times for Sundays and holidays. An employee may accrue up to 40 hours of compensatory time off per year. At April 30, 2015 the estimated unused accrued compensatory time off amounted to approximately \$16,666.43. The amount attributed to enterprise funds could not be determined. The amount to be paid from current resources is not significant.

On December 30, 2010, the City assumed a promissory note in the amount of \$305,000.00 from Community Bank and Trust to finance the purchase of certain tracts of land of Briarbrook Golf and Country Club. Payments are due monthly at \$4,737.12, with 3.75% stated interest, final payment due by September 11, 2018.

On November 4, 2005, the City assumed a promissory note in the amount of \$99,952.00 from the Missouri Department of Natural Resources to finance the costs of the design, acquisition, installation and implementation of energy conservation measures for the Police Department building. Payments are due semiannually at \$3,123.50, with no stated interest, final payment by August 1, 2021.

II.B.4 Capital Lease Obligations

On January 19, 2010, the City entered into a lease-purchase agreement with Commerce Bank, N.A. for furniture, fixtures and equipment. On March 21, 2012 the City refinanced the lease - purchase. The lease is currently payable yearly at \$17,339.39, final payment due September 1, 2017, subject to non-appropriation of funds. Total cost of equipment is \$267,752.10.

On June 1, 2004, the City transferred \$512,943.75 from the Debt Service Fund to an escrow account to provide for refunding of \$500,000.00 of Series 1994 General Obligation Bonds. GASB Statement No. 7, Advance Refunding Resulting in Defeasance of Debt, provides that refunded debt and assets placed in escrow for the payment of related debt service be excluded from the financial statements. As of April 30, 2011, the outstanding balances of bond series that have been refunded and defeased in substance by transferring funds to irrevocable escrow accounts to provide for all future debt payments was \$470,000.00

II.D. ENTERPRISE FUND DEBT

II.D.1 Capital Lease Obligations

On March 18, 2014 the City entered into a lease-purchase agreement with Southwest Missouri Bank for the purchase of Route Z and JJ Highway lift station and wastewater treatment collection system. The lease is currently payable semi-annually at \$29,913.63, final payment due March 20, 2020, subject to non-appropriation of funds. Total cost of equipment is \$335,280.

On July 16, 2013, the City entered into a lease-purchase agreement with U.S. Bankcorp for generators. The lease is currently payable semiannually at \$30,018.45, final payment due July 12, 2017, subject to non-appropriation of funds. Total cost of equipment is \$231,500.00.

On June 18, 2013, the City entered into a lease-purchase agreement with Commerce Bank, N.A. for utility tractor and brush hog. The lease is currently payable semiannually at \$10,997.18, final payment due July 12, 2015, subject to non-appropriation of funds. Total cost of equipment is \$44,002.56.

On June 7, 2006, the City entered into a lease-purchase agreement with Missouri Association of Municipal Utilities for acquisition and installation of fluoridation equipment at each of its seven existing well sites. The lease is payable monthly at \$2,000.00 for the first three months and \$3,000.00 for the final three months plus interest at 4.02% on the outstanding balance of the lease. Final payment is due October 20, 2015, subject to non-appropriation of funds. Total cost of the project is \$257,000.00.

Deposits

Custodial Credit Risk – Custodial credit risk is the risk that in the event of a bank failure, the City’s deposits may not be returned to it. RSMo Chapter 110 requires that public funds shall be secured by the deposit of securities of the character prescribed by section 30.270, RSMo. The value of which shall at all times be not less than one hundred percent of the actual amount of the funds on deposit with the depository less the amount, if any, insured by the Federal Deposit Insurance Corporation. All deposits were legally secured at April 30, 2015. The City does not have any other policies for custodial credit risk.

At April 30, 2015, the City’s carrying amounts of deposits was \$3,422,531.84 and the bank balance was \$3,608,598.83. 100% of the bank balance was held by two banks resulting in a concentration of credit risk. Of the bank’s balance, \$500,000 was covered by Federal Depository Insurance, \$4,030,427.47 was collateralized with securities held by the Federal Reserve Bank.

Investments

The City’s policies and applicable laws regarding investments are discussed in Note I.E. During the year ended April 30, 2015 the City invested idle funds in interest bearing deposit accounts with the Community Bank & Trust and Southwest Missouri Bank.

IV.A. EMPLOYEE PENSION PLAN

A. Plan Description

The City of Carl Junction participates in the Missouri Local Government Employees Retirement System (LAGERS), an agent multiple-employer public employee retirement system that acts as a common investment and administrative agent for local government entities in Missouri. LAGERS is a defined benefit pension plan which provides retirement, disability, and death benefits to plan members and beneficiaries.

A. Plan Description (Continued)

LAGERS was created and governed by statute section RSMo. 70.600 – 70.755. As such, it is the system’s responsibility to administer the law in accordance with the expressed intent of the General Assembly. The plan is qualified under the Internal Revenue Code Section 401(a) and it is tax exempt.

The Missouri Local Government Employees Retirement System issues a publicly available financial report that includes financial statements and required supplementary information. That report may be obtained by writing to LAGERS, P.O. Box 1665, Jefferson City, MO 65102 or by calling 1-800-447-4334.

B. Funding Status

Full-time employees of the City of Carl Junction contribute 4% of their gross pay to the pension plan. The June 30th statutorily required contribution rates are 10.4% (General) and 8.5% (Police) of annual covered payroll. The contribution of plan members is determined by the governing body of the political subdivision. The contribution provisions of the political subdivision are established by state statute.

IV.A. EMPLOYEE PENSION PLAN (CONTINUED)

The annual required contribution (ARC) was determined as part of the February 29, 2012 and February 28, 2013 annual actuarial valuations using the entry age actuarial cost method. The actuarial assumptions as of February 28, 2014 included: (a) a rate of return on the investment of present and future assets of 7.25% per year, compounded annually, (b) projected salary increases of 3.5% per year, compounded annually, attributable to inflation, (c) additional projected salary increases ranging from 0.0% to 6.0% per year, depending on age and division, attributable to seniority/merit, (d) pre-retirement mortality based on 75% of the RP-2000 Combined Healthy Table set back 0 years for men and 0 years for women and (e) post-retirement mortality based on 105% of the 1994 Group Annuity Mortality table set back 0 years for men and 0 years for women. The actuarial value of assets was determined using techniques that smooth the effects of short-term volatility in the market value of investments over a five-year period. The unfunded actuarial accrued liability is being amortized as a level percentage of projected payroll on an open basis. The amortization period as of February 29, 2012 was 21 years for the General division and 30 years for the Police division. The amortization period as of February 28, 2013 was 25 years for the General division and 28 years for the Police division.

The actuarial assumptions were changed in conjunction with the February 28, 2011 annual actuarial valuations. V. RISK MANAGEMENT

The City is exposed to various risks of loss related to torts; theft of; damage to, or destruction of assets; errors and omissions; injuries to employees; employees' health and life; and natural disasters. The City is a member of the Missouri Intergovernmental Risk Management Association that carries pooled high risk insurance which manages these various risk factors.

VI. GRANT PROGRAM INVOLVEMENT

The City receives Federal and State Grants for specific purposes that are subject to review and audit by Federal and State Agencies. Such audits could result in a request for reimbursement by the Federal and State Agencies for expenditures disallowed under the terms and conditions of the appropriate agency. In the opinion of City management, such disallowances, if any, will not be significant to the City's financial statements.

VIII. UNACCOUNTED FOR CASH RECEIPTS AND DISBURSEMENTS

The City was unable to reasonably determine the amount of cash collected in the Municipal Bond and Municipal Court accounts for the year ended April 30, 2015. On June 18, 2014, the Municipal Judge identified discrepancies in the Court Clerk's case

files. The Court Clerk was unable to sufficiently explain the discrepancies and was terminated in June, 2014. City officials, after conducting an internal investigation which noted additional concerns, contacted the Missouri State Highway Patrol for assistance, and requested the State Auditor's office to perform an audit of the Municipal Court.

The State audit found at least \$65,373 in recorded cash receipts that were not deposited and are missing. In addition, another \$31,141 may be missing based on discrepancies in case files. Management, based on consultation with its insurance carrier and legal counsel, believes that the ultimate settlement of claims for this loss will not exceed its insurance coverage, which totals \$105,000.

IX. LITIGATION

The City is party to various legal proceedings that normally occur in the course of governmental operations. The financial statements do not include provisions for loss on contingencies that may result from these proceedings, due to the insurance coverage maintained by the City. The City feels that any settlement or judgment not covered by insurance would not have a material effect on the financial condition of the City.
