Sealed Bids for West Briarbrook Lane Stormwater Drainage Ditch will be received by the City of Carl Junction, Missouri at Carl Junction City Hall, 303 N. Main St., Carl Junction, MO 64834, until 10:00 a.m. local time on November 13, 2024, at which time the Bids received will be publicly opened and read.

The Work to be performed under the Base Bid provisions of this contract generally consists of the following:

Construction of stormwater ditch improvements consisting of grading/shaping, installation of a vegetated concrete block mat, and seed & mulch.

Bids shall be on a lump sum and unit price basis as described in the Bid Form.

No Bidder may withdraw his bid within ninety (90) calendar days after the actual date of the opening thereof.

Attention of the Bidder is particularly called to the requirements as to conditions of employment to be observed, and that the Bidder must comply with the payment of hourly wage rates, including all fringe benefits, as established by Section 290.210-340, RSMO, as amended in 1993, pertaining to the prevailing hourly rate of wages and including fringe benefits, as established by the Department of Labor and Industrial Relations of the State of Missouri. A copy of the determination is provided within the Supplemental General Conditions.
